ORDER

(with respect to respondents Michael Cody and Donald Nason)

WHEREAS Staff of the Commission filed a Statement of Allegations against, *inter alia*, Michael Cody and Donald Nason on 14 March 2008.

AND WHEREAS Staff filed an Amended Statement of Allegations against, *inter alia*, Michael Cody and Donald Nason on 2 June 2008.

AND WHEREAS Staff filed a Second Amended Statement of Allegations against, *inter alia*, Michael Cody and Donald Nason on 23 October 2008.

AND WHEREAS Staff entered into a Settlement Agreement with the respondents Locate Technologies Inc., Tubtron Controls Corp., 706166 Alberta Ltd. and Lorne Drever which was approved by the Commission pursuant to section 191 of the *Act* on 25 August 2008;

AND WHEREAS Staff entered into a Settlement Agreement with the respondents Bradley Corporate Services Ltd. and Harry Niles which was approved by the Commission pursuant to section 191 of the *Act* on 4 November 2008;

AND WHEREAS a Second Consolidated and Amended Notice of Hearing was issued on 4 November 2008 scheduling a hearing on 20 January 2009 pursuant to sections 184, 185 and 186 of the *Act* with respect to the respondents Michael Cody and Donald Nason;

AND WHEREAS counsel for Staff and counsel for the respondents Michael Cody and Donald Nason filed an Agreed Statement of Facts on 19 January 2009 which includes admissions by the respondents Michael Cody and Donald Nason that they violated New Brunswick securities law;

AND WHEREAS counsel for Staff and counsel for the respondents Michael Cody and Donald Nason have jointly requested an adjournment of the 20 January 2009 hearing to allow time for the parties to prepare submissions on sanctions and have agreed upon a timeline for filing of submissions on sanctions;

NOW THEREFORE IT IS HEREBY ORDERED THAT:

- (a) the hearing scheduled for 20 January 2009 with respect to the respondents Michael Cody and Donald Nason is adjourned to **17 March 2009** , and
- (b) Staff and the respondents Michael Cody and Donald Nason are to file written submissions on sanctions by **6 February 2009** .
