## **ORDER**

WHEREAS on 15 October 2007 Staff of the Commission made a motion seeking a Temporary Order that, *inter alia*, the respondents cease trading in securities and provide certain information.

AND WHEREAS Staff presented evidence that the respondents have not complied with New Brunswick Securities law.

AND WHEREAS Locate Technologies Inc., Tubtron Controls Corp., 706166 Alberta Ltd., and Lorne Drever had retained Barry R. Morrison, Q.C. to act as their counsel in this matter.

AND WHEREAS the respondents Bradley Corporate Services Ltd., Harry Niles, Michael Cody, and Donald Nason were duly served with the Notice of Motion and supporting affidavit in this matter and they did not appear at the date and time set for the hearing of Staff's Motion.

AND WHEREAS Locate Technologies Inc., Tubtron Controls Corp., 706166 Alberta Ltd., and Lorne Drever indicated their consent to the issuance of a Temporary Cease Trade Order in this matter by the Commission.

AND WHEREAS the Commission issued a Temporary Order which expires 15 April 2008.

AND WHEREAS Staff of the Commission filed a Statement of Allegations in this matter on 14 March 2008.

AND WHEREAS Staff of the Commission have made motion for an order against the respondents to prohibit them from trading in any securities until this matter is determined.

AND WHEREAS the Commission is of the opinion that it is in the public interest to make this Order.

## NOW THEREFORE IT IS HEREBY ORDERED THAT:

- a. pursuant to section 184(1)(c) of the Securities Act no person shall trade in the securities of Locate Technologies Inc. and Tubtron Controls Corp.;
- b. pursuant to section 184(1)(c) of the Securities Act, Locate Technologies Inc., Tubtron Controls Corp., 706166 Alberta Ltd., Lorne Drever, Harry Niles, Michael Cody, and Donald Nason shall cease trading in all securities; and
- c. pursuant to section 184(1)(d) of the *Securities Act*, any exemptions in New Brunswick securities law do not apply to any of Locate Technologies Inc., Tubtron Controls Corp., 706166 Alberta Ltd., Lorne Drever, Harry Niles, Michael Cody, and Donald Nason

until the Commission reaches a final determination in this matter, or until otherwise ordered.
