

# DIRECT COMPENSATION – PROPERTY DAMAGE UNDERTAKING

## Section 254.1 of the INSURANCE ACT, R.S.N.B. 1973, C.I-12

Under section 254.1 of the *Insurance* Act, an insured is entitled to recover, based on the degree of fault of the insured, for the damages to his or her automobile and its contents and for loss of use from his or her own insurer as though the insured were a third party.

All insurers that hold a New Brunswick licence to carry on automobile insurance are bound by section 254.1 of the *Insurance* Act. Insurers that are not licensed in New Brunswick, can file an undertaking with the Superintendent to be bound by section 254.1 of the *Act*.

To withdraw an undertaking, an insurer must provide written notice to the Superintendent in advance of withdrawing.
