

Portal Standard Contracts User Guide

Introduction

This is a guide to using the online portal of the Financial and Consumer Services Commission of New Brunswick (the Commission) for Standard Contracts. The portal allows a Standard Contract (Trustee) user to apply to register a new Standard Contract or submit a related filing.

Please take a moment and review the Portal Basics User Guide to learn how to create an account, how to navigate the portal, how to make selections from dropdowns, and how to upload documents. It is available on the portal FAQ page at http://fcnb.ca/portalfaq.html.

The portal may be found online at https://portal.fcnb.ca and offers the following functionality to a Financial Institution Representative user:

- Start a standard contract registration application and save as a draft
- Upload document(s) required for a standard contract registration application
- Validate and submit a standard contract registration application
- Pay the standard contract registration fee online
- Download a declaration form
- View the current status of an application
- Upload additional documents or provide additional information, if further information is required to process the application
- · View a submitted or registered application for a standard contract or related filing
- Submit an application for an amendment to a standard contract
- Submit an application for the closure of a standard contract to new clients
- Submit an application for the discontinuance of a standard contract
- Add and edit delegated parties

Applying to register a Standard Contract


Once you have successfully signed in, you will see the main menu page. Here you will see, at the top left of the page, a menu with an option for 'Standard Contracts'. Click on this link to return to this page at any time.



My Standard Contracts

Click on the menu option for Standard Contracts and you will see a (initially empty) list of standard contracts associated with your account. To begin a new standard contract application, select the 'Add' button on the right side of the page.

At each of the following pages in the application you will be asked to provide information or to make certain selections. Here you will note a yellow box containing an explanation of what you are required to do at this step. You will find this explanatory yellow box on most pages. Please carefully read these instructions for each step of the application process.




Standard Contract Registration

Contract type

Select the type of standard contract you wish to apply for from the drop down box (click the little down arrow on the right to reveal the available options). Click 'No' or 'Yes' to indicate if the standard contract will be offered in both English and French and select the primary language for the standard contract.


Note: Please ensure you select the correct type of standard contract because once you have clicked 'Next', your standard contract type cannot be changed.



Draft application

CRA number:

A draft application is automatically created once you click the 'Next' button. If you navigate back to the main page you will now see that your application is on your list of standard contracts, identified as having a 'Draft' status. You may continue to edit your application by clicking the Transaction ID link (160000769 in this example) under the Transaction ID heading.




This will take you to the Standard Contract details page. Click the button 'Continue Editing' to return to editing your application. This will take you back to the 'Contract type' page. Click 'Next' to proceed.


Financial institution details

Enter the required information and click 'Next' to move to the next step.





Download financial institution declaration form

This step is only applicable for LIF and LIRA contracts. Click the 'Download' button to download a declaration form, sign it and be ready to upload it at the next step.



Upload documents

On this page, you will upload required documents. The actual documents required are different depending on the type of standard contract being registered. Required documents are marked with a red asterisk (*). If a required document has not been successfully uploaded and you click 'Next', an error message will appear and you will have to upload the document to proceed.


- Place all files to be uploaded in the same directory or folder on your computer.
- . Click the "Browse" button for a particular item to upload. A window to access files on your computer will appear. Browse to the folder containing your files.
- Select the file(s) on your computer (hold down the CTRL key to select multiple files) and click "Open" in the window. The text box to the left of the "Browse..." button should now indicate the selected files.
- Repeat this process for each item requiring document upload. Add any documents not within a particular category under the "Additional documents" item.
- Once you have selected files for all items, click "Upload". This will upload all your documents simultaneously.
- Once complete, uploaded documents will appear with the item with respect to which they were uploaded. Please ensure that all documents you wanted to upload are listed. Add further documents by clicking "Browse..." again. (Note that an additional Browse and Upload will add to the uploaded list and will not replace previously uploaded files. To delete a particular uploaded file, click the little garbage can to the right of the file.)

Please note: If you do not have the original CRA letter assigning the identification number, then please upload the most recent CRA letter referencing the identification number and the retirement savings arrangement name.

Validation and confirmation

Once all documents have been uploaded you will be asked to validate and confirm your application. At this point it may be a good idea to review the information provided by navigating back through your application using the 'Previous' button and then navigating forward again to this page. When you have completed the application to your satisfaction, click the confirmation check box and then click the 'Next' button to proceed.



Fees and Payment

You have the option to pay online using credit card or Interac debit card, or send in payment separately. Note: A standard contract will not be registered until full payment is received.



Submitted application

Once your application has been successfully submitted, you will see your application as 'Submitted' in the list of standard contracts associated with your account. The list is sortable by clicking on any of the headers.

Once a standard contract has been approved, you will be able to amend the standard contract, close the standard contract to new clients and discontinue the standard contract by completing the applicable online process. To make any of these types of changes to a registered standard contract, click on the Transaction ID link (160100282 in this example) to get to the Standard Contract Details page.



From this page you may also view a 'Submitted' or 'Approved' standard contract by clicking the 'View Standard Contract' button.



A standard contract registration may only be discontinued and closed if one of the two following conditions is met: • The specimen plan has active contracts and these contracts have been transferred to another specimen plan, or • The specimen plan has no active contracts.	
In the case of the former, you will be required to provide details of resignation of the trustee, as well as acceptance by the successor trustee. This must include the registration numbers of the specimen plans to which the contracts are transferred.	
In the case of the latter, you must provide a letter from the trustee confirming there are no active contracts remaining.	
In both the former and latter cases, you must also provide a copy of a letter from CRA confirming they have been notified of the discontinuance/transfer, as the case may be.	
After indicating whether there are active contracts by clicking either "Yes" or "No", please provide any additional details relating to the discontinuance, which you wish staff to consider or be aware of.




